SUMMARY

Ergonomics is of Greek Origin: Ergo = Work, Nomos = Laws of, literally translated the “Laws of Work.” Occupational Ergonomics impacts everything we do at work. When the principles of ergonomics are applied the benefits range from reducing and preventing musculoskeletal injuries to improving product quality to boosting productivity. Good ergonomics is good economics positively impacting the company bottom line. Attendees will learn about the essentials of ergonomics (including making the business case); understanding the risk factors and prevention strategies for musculoskeletal injuries of the upper limbs, back, and lower limbs; using ergonomic risk assessment tools to quantify work-related hazards; and developing successful ergonomics programs.

SPEAKER

Dr. JAMES D. MCGLOTHLIN is a Certified Professional Ergonomist and Professor Emeritus of Health Sciences in the College of Health and Human Sciences at Purdue University. Dr. McGlothlin is the former Director of the Graduate Program in Occupational and Environmental Sciences and the NIOSH Training Program Grant (TPG). Dr. McGlothlin is the author of more than 250 scientific, technical, and government reports and is the Co-Editor of the acclaimed book, Occupational Ergonomics: Theory and Applications, now in its 2nd Edition.

CEU Information



CSPs

The Board of Certified Safety Professionals will allow one credit towards maintenance of certification for a two-day attendance at the Michigan Safety Conference. A half credit can be earned by attending one day. CSP's will be responsible for documenting their own attendance.

CIHs

Certified Industrial Hygienists can earn CM points at a rate of a) Claim 3 hours for each half day of attendance, or b) 0.167 CM point per each hour of technical content in the CM Areas of IH, Safety, or IH Ethics. Fractional points are allowed once the one-hour minimum is achieved for IH or Safety events (e.g. 1.5 hrs = 0.25 CM point). *Excludes* the non-technical portions such as generic welcome speeches, participant introductions, breaks, meals, networking, exhibitor time, roundtables or discussions with unspecified topics, and/or social tours.

CONTINUING EDUCATION UNITS — GENERAL

Several divisions will offer CEUs through Grand Valley State University for attendance at their programs. Attendees will be required to complete a request form available from divisional representatives at the conference.

CHSPs

The International Board for Certification of Safety Managers will recognize one contact hour of continuing education for each one-hour break-out session for the CHSP designation.

NREPs

Individuals certified by the National Registry of Environmental Professionals are allowed to apply CEUs obtained through documented attendance at the Michigan Safety Conference to NREP's continuing education requirements.

CRSPs

BCRSP has awarded attendance at the Michigan Safety Conference 1.0 CMPs. Call the headquarters office to obtain the CMP approval code. MCPs are accrued by Canadian Registered Safety Professionals who are certified by the Board of Canadian Registered Safety Professionals.

DIPLOMATE ENVIRONMENTAL ENGINEERS

The American Academy of Environmental Engineers will recognize participation in the Michigan Safety Conference as a legitimate continuing education activity for its Diplomates (certified engineers).

PROFESSIONAL EMERGENCY MANAGER (PEM)

The Michigan State Police, Emergency Management and Homeland Security Division will accept a certificate of attendance from the Michigan Safety Conference for the "Attend a Relevant Conference" Annual Continuing EM Participation credit, for the Professional Emergency Manager designation.

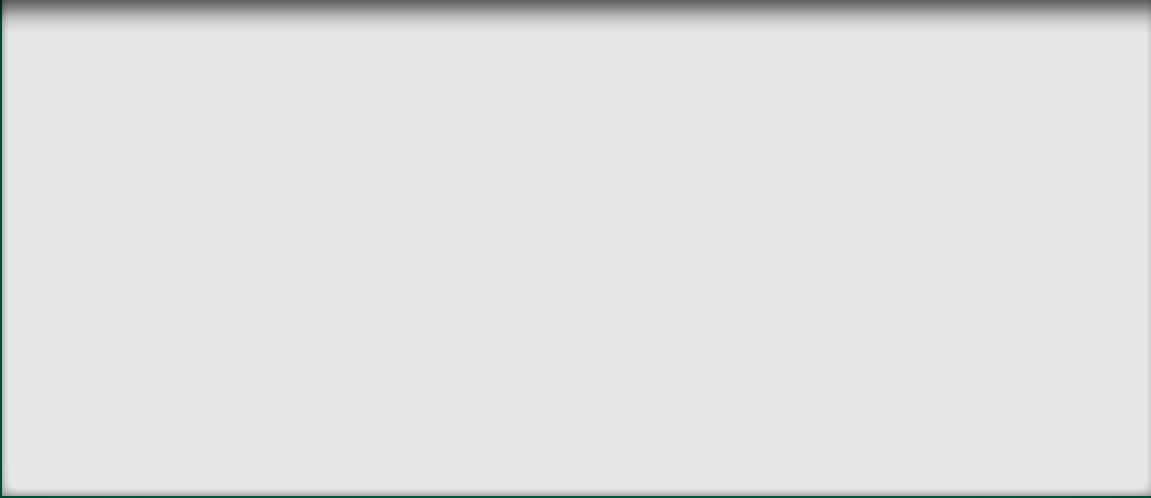
